A comprehensive understanding of STIs enables migrant workers to reduce violence against individuals affected by these infections. Supporting learning and awareness through sexual education is crucial in preparing migrant workers to be independent individuals capable of managing their health. - 3. Campaign: Organize awareness campaigns highlighting the importance of preventing sexually transmitted infections among migrant workers.

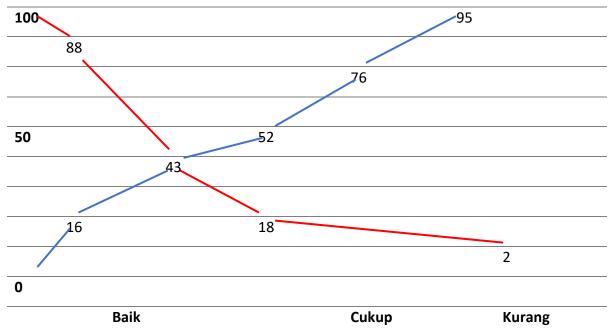
c. Evaluation

According to the pretest findings on knowledge regarding the implementation of sexual education for migrant workers in preventing the spread of sexually transmitted infections, the accompanying figure illustrates a notable increase in migrant workers' understanding. During the pretest, it was observed that 95% of participants had limited knowledge about the importance of sexual education for migrant workers in preventing the spread of sexually transmitted infections.

Following the implementation of sexual education for migrant workers in preventing the spread of sexually transmitted infections, the post-test results indicate a significant improvement, with only 2% of workers exhibiting limited understanding. This provides insight into the changes in knowledge and behavior among migrant workers after participating in sexual education activities.

The impact of sex education activities aimed at preventing sexual crimes against children demonstrates an increase in participants' knowledge after receiving education, as measured through pre-tests and post-tests using questionnaires.
